*Acceptable documentation includes a bill of sale and/or state title application.

This vehicle must meet current Audi Certified pre-owned guidelines for transfer eligibility:

- Vehicle must have originally been sold as Certified pre-owned on or after September 1, 2011.
- ▶ At time of proposed transfer, the Audi CPO Limited Warranty must be in effect, that is, the vehicle is within age & mileage limits.
- ▶ Vehicle must not have been totaled, stolen, exported from the US, or imported to the US from another country.
- ► The Audi CPO Limited Warranty is only eligible to be transferred from private owner to private owner and must be requested by the original purchaser of the CPO vehicle. **Dealership participation is excluded**.
- ► Transfer application must be submitted by the original Certified pre-owned owner within 30 days of vehicle sale.

Audi of America reserves the right to refuse transfer in the case of fraud, abuse, failure to meet transfer guidelines, or if the appropriate documentation is not submitted.
